Public revelation: Corruption in "...United Nations agencies, including the UN Human Rights Council." By Terry Glavin

To:- All members of the U.N. and others.

1) Our latest submission: Interest from two western provinces, Alberta and Saskatchewan, led us to make another try at resolving our mutual problem of the public funding of only the schools of one religion and no others. We suspected what we called some "funny business" in the treatment of our school issue by the U.N. Human Rights Committee and wondered about the possible involvement of "certain entities" as the reason, but we had no proof. Discouraged with the U.N. for a time, we didn't make another approach to the Committee until early in June 2020.

U.N. forms were dutifully filled out for a submission to the U.N.'s Human Rights Officer for "Freedom of Religion or Belief", Damianos Serefidis. The submission was titled "CRIPE – Canada-1, 2, 3". "CRIPE-Canada-1" is the "Model Questionnaire." "CRIPE-Canada-2" is the "Identity of Persons Concerned". "CRIPE-Canada-3" includes our "Documentation of Canada's Abuse" which covered 28 pages.

We were advised by Damianos Serefidis that there was no problem with the format, or content of the submission. He treated us a polite manner, but we received no further reply to questions to help the submission move though the following steps. Suspecting that the COVID-19 pandemic might be the reason, we patiently waited. To this day, two and one half years later, we have received no reply. Our submission was not even given a file number. Again, we were cut off from any contact with the U.N. Human Rights Committee.

2) Corruption at the U.N. confirmed: Having noted that our submissions to the U.N. for religious discrimination in Canada were being blocked by some entity, we had our suspicions, but no proof. Then, in November of 2020 a column in the Ottawa Citizen newspaper, by Terry Glavin, we could read the following: (With bolding added and type size changed.)

"The world's most gruesome despots carry on their depredations with impunity. Their police-state economies have been integrated into the markets of the western democracies, and they have been allowed to insinuate themselves into veto positions in several leading United Nations agencies, including the UN Human Rights Council. (insinuate: to introduce by gradual, subtle, and stealthy means.) We were relieved to know that our suspicions were correct. We no longer felt alone.

I messaged Terry, but he did not reply. However, this was confirmation of what we suspected. The above quote explained why we were cut off from any communication with the Special Rapporteur for Freedom of Religion or Belief and his help to resolve the issue we raised about religious discrimination perpetrated by the governments of the provinces of Ontario, Alberta, and Saskatchewan, and the government of Canada.

The purpose of these sections is to impress on the U.N.'s Human Rights Committee/Council in Geneva, that they have a cleaning-up job to do. The fact that the United Nations harbours corruption, is a global scandal of the highest proportion.

The U.N. will get a corruption test when CRIPE re-submits its CRIPE-Canada-1-2-3

These posts have been sent, by email, to over 730 individual persons, politicians, embassies, human rights organizations, reporters, etc. which includes 24 different addresses at U.N. headquarters.

It is expected that the U.N. will give serious consideration to this message and will engage in the courtesy of a reply with assurances that all future human rights submissions will be considered in an appropriate manner.
